Village District be known as Aten Road Village District, the board approved.

Attorney Hanna noted that the purpose of Aten Road Village District is to maintain and repair Aten Road.

Jane Healy moved and Don Healy seconded to call the district Aten Road Village District.

Article 1 – Don Healy moved and Robert McLaughlin seconded to establish Aten Road Village District, the voters approved.

Article 2 – To choose, by ballot:

Commissioners, Clerk, Treasurer and Moderator to serve up to the first annual meeting, which must be held between January 1 and May 30, 2017.

Attorney Tom Hanna passed out ballots. After completion by the voters, Atty. Hanna announced the results of the 16 ballots as follows:

Commissioners – Donnal Healy, Robert McLaughlin and Jim Amrein

Moderator - Nicholas Healy

Treasurer – Joyce Healy

Clerk - Gail Demasi

There was a round of applause for the newly elected officials of Aten Road Village District.
