SELECTMEN'S MEETING MINUTES

March 17, 2014

The meeting opened at 7:00 PM with the Pledge of Allegiance.

Attendees included Arnie Stymest, Selectman, Stephen McGerty, Selectman Chairman, Harry Power, Compliance Officer, Jim Coffey, Town Administrator and Patricia Putnam, Administrative Assistant. Several attended the meeting as on lookers.

APPOINTMENTS:

7:00 - Harry Power - presented a building permit for Tax Map # 119, Lot # 4 on Red Coat Lane - the board approved it.

7:30 - Public Hearing on parking issues on Shedd Hill Road, near the Marina.

Chief LaMothe, Deputy Chief Sarcione and Constable Vaillancourt met with the board to discuss the problems created along Shedd Hill Road when there are programs at the Highland Lake Marina. Joe Sarcione related that he had all he could do to get through with his pickup truck when there was a substantial fire at Merriewood. He reported that the Town Landing was filled with vehicles and boat trailers and he was challenged to turn around his truck there. PJ LaMothe noted that there is no room for any emergency vehicles to pass through there, most of the summer season. David Vaillancourt said there is a State Ordinance in the RSA's to prevent impeding traffic, which could result in a fine or towing, at the owner's

expense.

Mrs. Chris Madden questioned why the parking restriction should be just around the Marina. She reported that parking has restricted passage all along the road. John Lightbody also reported that there have been problems all along the road for years. Dean Huber thought alternate side parking, around weather, is not practical.

It was concluded that the board should write up a policy governing the parking be restricted to one side of Shedd Hill Road for most of the length of said road. Arnie Stymest thought the restriction should be along the West side of the road. Steve McGerty wanted to wait until John Halter is present before deciding anything. The public hearing was continued to March 24, 2014 at 7:30 PM. When the policy is written it will be noticed on the Town's Web Site and published it the paper.
