SELECTMEN'S MEETING MINUTES

June 6, 2011

Selectman Stymest opened the meeting at 7:00 P.M with the Pledge of Allegiance. Chairman Stymest stated that no one is to speak during appointments unless recognized by the Chairman. He also stated, that there will an open session for anyone without an appointment.

7:00 P.M. Harry Power, Code Compliance Officer

Mr. Power mentioned that the Selectmen should meet with the Sullivan Selectmen concerning Bowlder Road. Selectman Halter asked if the resident(s) on Bowlder Road has a lot of friends. (Adding to the traffic count.) The next issue discussed was the section of Juniper Hill Road along the Holland property. Mr. Power stated that the original layout was three rods wide. He went on to state that there have been two court decrees concerning the property and that only 3-4 of the vehicles on the property are registered.

The court petition (Jennison & Willard) sent by Attorney Fernald needed a signature page correction and Jim Coffey will try to get it corrected for signing on Friday.

The subject of Article 8, Town Hall, was brought up and it was agreed that the \$40,000 appropriation was for engineering and planning as stated in the article, and not transferable to any other purpose.

7:15 P.M. Jane McDermott was not present.

7:20 Patricia Putnam, Treasurer, ZBA and Planning Board Secretary Patricia Putnam brought a letter to be signed by the Selectman and the ZBA to the New Hampshire Department of Transportation concerning traffic near Mr. Mike's.

Selectman Halter, seconded by Chairman Stymest, moved to approve the letter and the motion passed 3-0.

7:27: P.M. Selectman Halter, seconded by Selectman GrandPre' moved to enter non-public session under RSA 91-A:3 (c). Role call vote; GrandPre'-Yes, Halter-Yes, Stymest-yes.

7:55 P.M. The Board returned to public session. Chairman Stymest, seconded by Selectman Halter moved to seal the minutes. The motion passed 3-0.

Selectman GrandPre' stated that he would contact the Sullivan Selectmen to set up a meeting to discuss Bowlder Road.

The Board reviewed the road contract bids along with a summary spreadsheet compiled by Selectman Halter. After a brief discussion, Selectman GrandPre' moved to award the bid to David Vaillancourt. The motion was seconded by Selectman Halter and passed 3-0. The contract is for three years, renewable each year.

At 8:10 Selectman Halter, moved to adjourn, seconded Selectman GrandPre' and the motion passed 3-0.
