The other one down the road can't find a septic system, so they are installing now and expect an operation permit soon.

Fire Department/Fibercast Contract

Fibercast is not emailing the Town Administrator. The new contract is about \$60.00 more than we pay now. The Selectmen signed the Fibercast Contract. The Town Administrator gave it to Steve Rockwell – he promised to provide her with a copy.

New Truck – The slow production is delaying the truck. If we cancel the truck now there will be am increase in pricing. The price will stay the same if we do not get out of the pipeline. The body build has started but waiting on the chasis. Steve Rockwell will reach out to the Bank to see if there will be any financing issues. Michelle will determine if this has to go back to Town Meeting.

Article for Town Meeting To see if Town will vote to authorize the appointment, rather than the election of a Town Treasurer per RSA 41:26E <u>BOB MOTIONED TO PROCEED WITH THE WARRANT ARTICLE. STEPHEN</u> SECONDED. MOTION CARRIED.

BOB MOTIONED TO WAIVE RENTAL FEE ON TOWN HALL FOR THE HISTORICAL SOCIETY. STEPHEN SECONDED. MOTION CARRIED.

Stephen McGerty had a number of questions for the Town Administrator:

Steve requested a letter from the Auditors firing us. Michelle stated that we only received a phone call.

Steve thanked Chris Pong for his work on the finances and did a nice job, but had a number of questions.

What was found that was wrong with the books. Michelle said she didn't have a clear picture of the problem but can get Chris to help answer them.

Can municipal records be taken off the property? Michelle answered in the affirmative. Stating that they were public information. Is there a law that says they can't be removed from the office?

Does Chris Pong have a Bond?

He has insurance. Steve requested copy of insurance paperwork. Michelle said she would check with Chris and confirmed that he had his own business. Steve thought the town should have a copy of his papers. Michelle reminded the Selectmen that Chris wasn't paid for his work, but she would ask him if he wanted to provide that information. She also confirmed that Mr. Pong is a business owner. Bob asked Steve why we needed that. Steve wanted to make sure we didn't end

up in a situation like this. Michelle offered to invite Chris into the meeting. More conversation took place regarding balancing Town books.

Bob asked if there was anymore business to be brought before the board.
