## 7:15 Linda Clark, On-Line MV Renewals

Linda explained the plan to accept on line credit card payments for motor vehicle registration renewals on line. The IDC Web Service would process the renewals, the Town Clerk's office would print checks with special ink, provide an envelope and stamp. The charge would be \$1.50 per vehicle plus \$.35 per client and the town would charge \$1.00 for the processing and mailing back the registration to the client. The Town's charge could be changed if the postage increases. Linda said it would eliminate the end of day line when people get out of work. Samuel Lamphier asked about security and privacy with the one line process. The town's web site would provide a link to a separate web site. This process will go into effect October 1, 2018. The board approved the process.

- 1. Samuel Lamphier asked about the removal of the light at the Island Pond Beach. Bob Fee thought it could be replaced with a motion sensor light. Jim Coffey is still looking into who is paying for that light.
- 2. Chief Steve McGerty said the Fire Department sign is available for town information to be posted. Just let him know.

- 3. Chief Steve McGerty reported that they have found someone to letter the town logo on the side by side.
- 4. Chief Steve McGerty said there is still a speed problem on Kings Highway and wondered if a center line could be painted. Bob Fee said the Police Department could then issue center line violations. Jim Coffey said he was awaiting a Police Department report on their radar monitoring. Chief Steve McGerty felt the radar was placed near where the traffic was slowing down at the end of the road.
- 5. Chief Steve McGerty reported that they are going to hold a demo on the turbo draft CPR machine and are going back to the boat dealer to get a Mercury engine which will be less expensive than the Yamaha previously quoted.
- 6. Chief Steve McGerty asked about an update on the transfer station fence. He also thought the area in front of the fence could be cleaned up and the winter sand pile placed there. The selectmen felt that where the pile of sand is located now is safer for people stopping to get some.
