#### Old Business:

#### Tax Rate:

The Town does not have a rate as of this meeting. Still working with the Auditors on a daily basis to get them everything needed. The Town books are closed, but not set up in a format that the Auditor wants because of the antiquated software. This has been worked on daily and through the weekend. This will be worked on everyday until the town has their Tax Rate.

## Bookkeeping Plans Going Forward:

BMSI upgrade of software – the programs are intergrated with the State System. The upgrade is based on window/excel programming instead of Dos being operated currently.

Stephen McGerty asked about getting rid of the Treasurer position as an elected position and making it an appointed position.

This has to be brought up as a Warrant Article at Town Meeting and voted on by the Town Citizens.

As the Town gets larger we need someone with bookkeeping experience.

### Action Plan going forward:

- Fisical year ending June 2021 balances have been fully reconciled.
- We will continue to rely on outside resources to fully reconcile cash to current as to avoid similar experiences in the future.
- We will separate the cash reconciliation from the Treasurers office and reassign to another employee.
- Will develop an internal written reconciliation process to provide to those responsible for the cash reconciliation going forward.
- Will begin the process to upgrade our existing financial software including comprehensive training for those using the system.
- Close the books every month and present a report to the Select Board.

BSMI upgrade \$3500.00and the annual fee is already include in the budget. Training is included in the upgrade.

Chris motioned to go forward with the BSMI upgrade for software. Stephen Seconded. Motion Carried.

Direct Deposit – Pat has been working on this and gathering information. Will wait to see if there is money in the budget to implement this.

### **Protection Road:**

Ongoing research is being done. Mr Winship would like to come talk to the Board about this issue.

West Shore Road in Nelson was closed at the end of October because of a culvert between the lake and Mill Pond. Concerns for mud season. Logging trucks coming down Aten Road 3 or 4 times a day with full loads. Concerns about the travel on Aten Road, West Shore Road and North Shore Road in Stoddard. The roads very rutted and a heavier volume of traffic due to the closure of West Shore Road in Nelson.

Will check the Timber Permit to see when they should be done with the logging. Will also speak to David Vaillencourt Road Agent about this issue and have him check the roads.
