Karen Bell – Town Clerk/Tax Collector:

Discussed budget items she wanted to see changed from last year and items the Board had questions on. This will be tabled to gather more information and Karen will work with Michelle.

Harry Power – Compliance Officer:

130-113 – Jalbert – permit was not signed. He was out of compliance. He has sent in the \$50.00 check for the violation.

417-7 – Healy – building a new home with an ADU included. Does He need ZBA approval for the ADU? Harry asked the Town Lawyer. The Lawyer stated that the approval for an ADU from the ZBA is not limited to conversion on existing homes and new builds with an ADU should go before the ZBA for approval. Harry asked if language should be included in the building permit that an ADU will be involved in the construction on new dwellings?
