He informed Dian Mathews that the correct procedure for filing this Lot Merger was not followed. Specifically, this merger was not submitted to the Town of Stoddard Tax Assessor nor was it filed with the Cartographics company which maintains and updates the Tax Maps. Jim Coffey said that going forward, the Planning Board Secretary must file the Lot Merger with the Cheshire County Registry of Deeds, the Town of Stoddard Tax Assessor and the Cartographics company which maintains and updates the tax maps. This process and the responsibilities involved, will be added to the Planning Board Secretary's Job Description and Responsibilities.

Master Plan Committee Update:

Dian Mathews gave an update on the status of submitting the application for the MTAG Grant, technical assistance for updated the Master Plan. The next Master Plan Committee Meeting (consisting of Dean Huber, Dian Mathews, Jane McOsker and Harry Power) will be May 17, 2016. She said that more members are needed to serve on this committee.

This workshop is an informational one pertaining to SB146 – Accessory Dwelling Units (ADU's) taking effect on June 1, 2017 and US Supreme Court Decision – Reed v.
