SELECTMEN'S MEETING MINUTES

October 22, 2018

The meeting opened at 7:00 PM with the Pledge of Allegiance.

Attendees included Christopher Madden, Chairman of Selectmen, Charles Fosberry, Selectman, Robert Fee, Selectman, James Coffey, Town Administrator Harry Power, Compliance Officer and Patricia Putnam, Administrative Assistant. Several members of the public were in attendance.

- 7:30 Commissioner Joseph Cartwright noted that 1/2 of the County Budget is for salaries and benefits and another big item is utilities which have increased in cost.

7:45 Library Trustees, Stone Wall Repair and Proposed Memorandum of Agreement Angel Nicoletti and Alexia Currie presented a proposed Memorandum of Understanding between the Davis Public Library Trustees and the Town Administrator outlining what the Trustees will budget and pay for and what the Town will pay for at the Library. They will rewrite the document to be between the Trustees and the Board of Selectmen and will return on October 29th for further approval. The stones in the stone wall behind the library are shifting and there is concern that the children might be at risk for injury. The children's garden is that location. Our Town Realty has quoted \$1160.00 to correct the problem. Bob Fee moved and Charlie Fosberry seconded to hire Out Town Realty to do the repairs, the board approved.

Chief McGerty reported that the boat will be here in about 2 weeks and the agreement is to pay in net 30 days.

Chief McGerty said Engine 1, Engine 2 and the Tanker will be pump tested tomorrow. Chief McGerty reported that Home Depot has ethanol free, high test gas at \$10/gallon. The local gas station has it for \$3.45/gallon. He needs to procure 10 gallons to use for small equipment.

Chief McGerty asked if there was any update from the attorney on the liability of taking the rescue truck to a call without an EMT on board – Jim Coffey is to follow up with the attorney.

- 1. Charlie Fosberry inquired into if the Center Pond Resident had followed up and paid all the outstanding taxes. The answer is yes.
- 2. Charlie Fosberry asked if the other taxpayer was meeting the agreement and making payments as promised yes.
- 3. Charlie Fosberry asked what the Old Fire Station is used for answer from Chief McGerty was for storage. Charlie Fosberry said the building looks to be in poor repair the Chief agreed.

- 2. Discuss Selectmen's Office Days/Hours Jim Coffey suggested that the days the Office is open change to Monday, Wednesday and Thursday commencing January 1st. He feels the Thursday is necessary to have all the town officials available for any questions. Friday would not be a day that the office will be open.
- 3. Discuss Future Banking Options considerable interest may be earned if the town invests in the NH Public Deposit Investment Pool vs People's United Bank but the bank fees might eat up any increase in interest earned, which the Town does not pay now.
- 4. 2019-2020 SWRPC Dues Request for budget amount is up \$8.00 a year.
