4) Pioneer Lake dam~removal of beaver debris

- *Geoff cleared out beaver debris (three days of work, four boatloads, ~1,000 lbs of debris). Geoff had discussed with LPC and DES prior to debris removal*

- *Commission proposes building a “fence” around the culvert opening to keep the beaver from building up and making cleaning easy. John Lightbody confirmed that a similar structure had been built before and had been effective but needed to be replaced.*

- Loon Preservation Committee

- *Chicks had hatched so loon monitor had no concerns about lowered water level.*

5) Other~Barbara Cleveland

- *Mowing of trail: concerns about habitat destruction along trail, forever wild designation. Concerns about loss of 2 yellow lady slippers along trail. Commission will take this into consideration with future management decisions.*

- *Concerns about the suddenness of water being released. Would have preferred it be more incremental. Will be considered in the future – especially will be taken care of with fencing.*

- *Paul proposes Pioneer Lake Advisory Subcommittee – to be placed on September agenda*

- *Issues of posting meeting times on website. Commission will now be able to post updates on meetings in real time. Commission will post when meetings will be held – winter and summer hours, and will post (in a timely manner) when meetings are cancelled. They will also put out calls for agenda items during times of the year when meetings will likely be canceled due to lack of agenda item.*
