- ñ Michael & Brian stated they look forward to being a NH certified vehicle inspection site and an automotive repair garage. They will not be doing oil undercoating at this location. In answering questions from the Board they mentioned they have a NH licensed transport company lined up to transport hazardous by-products and wastes from their site. They will be a LLC Partnership and plan only to take in vehicles for repair and send them back out. None will be kept for recycled parts. No decision has been made yet on whether they will do towing. Angel mentioned the NH DES has an Environmental Compliance Notebook available specifically for the automotive industry.
- ñ Harry Power, Stoddard Compliance Officer, listed as his concerns regarding the business; Oiling and undercoating, clutter and unregistered vehicles (RSA 236) on the property. Harry also mentioned there was an open item on Micheal's 2011 construction approval for an apartment. Michael said the apartment has not been completed yet but should be by 2015. Harry also said the Board should be careful what they approve as their deicision will carry forward to the next owners.

 granting the Special Exception with the following conditions; no
 undercoating or oiling to be done on the site, the business pass an
 inspection by the Stoddard Fire Department, no more than two (2)
 unregistered or uninspected vehicles on the site at any time and no
 outside storage of parts. The owners of the business were in agreement
 with the conditions.
